### SANITATION NOTICE

The Commissions of Cullman, Winston, Morgan, and Lawrence Counties, and the City of Hanceville have adopted a resolution requiring mandatory residential sanitation pick-up. Cullman Electric Cooperative has contracted with each of the above referenced Commissions to serve as the billing agent for such services. Cullman Electric Cooperative will add sanitation charges to your account if you are located in Cullman, Morgan and Lawrence Counties, Garden City, or the City of Hanceville. If your residence is located in the city limits of Cullman you will not be billed for sanitation services by Cullman Electric. ### MEMBERSHIP GUIDELINES

The applicant(s) agree(s) to adhere to the rules, regulations, rates and bylaws of the cooperative as those rules now exist or as amended by the cooperative. A complete copy of the bylaws and schedule of rules & regulations of the cooperative is available upon request and on the cooperative website. The rate schedule is available upon request. The applicant agrees to promptly pay all charges incurred as a result of membership including cost of collection and attorney fees. In consideration of the admission of the applicant to membership and the supply of electric power to the applicant, applicant hereby grants or agrees to grant unto the cooperative an easement for the construction and maintenance of power lines over, under or across any and all portions of the property to be served as well as any adjacent property owned by the applicant. The applicant agrees to execute any and all documents necessary to provide such easement. Cullman Electric Cooperative shall maintain the right to cut any trees as deemed necessary for the protection of electrical facilities.

Applicant authorizes the cooperative's board of trustees to subscribe to "Alabama Living" on their behalf and authorizes the subscription price thereof to be deducted from any funds accruing in their favor, so as to reduce such funds in the same manner as would any other expense of the cooperative.

Applicant authorizes all future transactions regarding this account and/or any additional accounts may be conducted via telephone, the Internet, and other forms of communication without a written form of agreement or a signature.

Applicant understands that additional charges may appear on each monthly bill, such as Operation Round-Up and Volunteer Fire Dues, and can be removed at any time with proper notification. Applicant also understands that the cooperative provides billing services for certain water systems, municipalities and other governmental bodies for water, sewer and other services. The water systems, municipalities or other governmental bodies provide the names and locations of those members to be billed for services. If you believe that you should not be charged for services billed, you must contact the appropriate water system, municipality or other governmental body assessing the charge and request that your name be removed from the list of customers to be charged. These services are automatically billed, per account, at the time services are established.

Acceptance of services by the applicant shall constitute a contract between the cooperative and the applicant and said contract shall be governed by this agreement and the by-laws of the cooperative.
