Security Lights will only be installed at rental property at the property owner's request. In this case, the property owner will be billed for the security light. All security lights require a 24-month contract. If the light is removed within the 24-month period, the member is responsible for the remainder of the monthly charges during the contract. Charges will continue to be billed monthly, or if member discontinues service at that location, total unpaid balance will be due on the final bill.

If member wishes to have an additional pole installed, the member will be required to pay for all labor and materials for said installation in addition to the regular light installation charge.
